

Mosman Festival of Sculpture 1 – 26 March, 2010 (80 sculptures in shop windows)

Conditions of Entry

1. Applicants must be current full members of the Sculptors Society.
2. Up to three sculptures may be entered, though all works may not be accepted, especially if we have a great many entries. Selection is at the discretion of the Committee and no correspondence will be entered into. In addition, the exhibition venue manager retains the right to require the Society to withdraw any work for any reason.
3. All works must be free standing, new to the Mosman exhibition and the sculptor's original work.
4. If the shop requires a plinth, it must be in good condition and freshly painted black or white.
5. All sculptures must be for sale. No 'price on application'. If you are registered for GST, your price must include GST and you are responsible for remitting the GST to the ATO.
6. **Applications for entry close Friday 15th January, 2010.** All information requested on application form must be provided.
7. **Exhibition set up: Thursday 25th to Saturday 27th February 2010.** Installation of sculpture is to be arranged between the sculptor and the shop. You will be advised the address and phone number of your shop with your acceptance.
8. **Exhibition dismantling: Saturday 27th March to Monday 29th March** (by arrangement with your shop)

Include with your application

1. Photographs that clearly show your proposed entry, labelled with your name, title of work, material and dimensions of the work. Note that photographs must show good contrast, have an uncluttered background, and be of a quality fit for reproduction in print.
2. Your entry fee of \$40. This may be refunded if your application is unsuccessful
3. Stamped and self addressed envelope for notification of your results and return of photographs
4. Photos may also be emailed to sculpt1@bigpond.net.au. Please limit size of JPEGs to 1MB and label each image with your name and title of work. (Please make sure you post the application form, cheque for \$40 & stamped addressed envelope)

Please read and sign the following

1. I have read the conditions of entry above and agree to be bound by them.
2. I appoint the Society as my agent to offer the work(s) for sale on my behalf through the Mosman Village Retailers Association.
3. I accept full responsibility for any damage to, loss or theft of my exhibited work(s).
4. I agree to a 25% commission payable on all sales (5% commission to the Sculptors Society and 20% to the Mosman Village Retailers Association), plus credit card charges (if applicable), and that this will be deducted from any money payable to me.
5. I certify that the art work is my original work and does not breach any other artist's copyright.
6. I certify that my works will be of sound and robust construction and will pose no danger to the public.
7. I give permission for photos of my work to be used in promotion for the exhibition and the Society
